## Infiniti Home Care PCP Job Description

#### **GENERAL STATEMENT OF DUTIES:**

Under the direction of supervisor/manager, provides personal care, comfort measures and homemaking services to clients in the home setting by performing the following duties:

#### **DUTIES AND RESPONSIBILITIES** include the following.

#### **ESSENTIAL DUTIES ARE:**

- Assists the client with or provides personal care as assigned by the plan of care. Personal care
  duties include, but may not be limited to: bathing, care of hair, skin, and mouth, toileting, dressing,
  transfer, ambulation, medication reminding.
- Performs light housekeeping duties sufficient to keep the client safe in the home. Housekeeping duties include: making and changing bed, cleaning bathroom, personal laundry, cleaning kitchen area, and shopping and errands.
- Prepares and serves meals.
- Documents activities performed in the client's home at the time of the visit.
- Documents client concerns, and client difficulties, and reports the same to supervisor or manager.
- Provides services when scheduled.
- Communicates promptly to Agency and client any schedule change.
- Completes and submits required paperwork accurately and on time.
- Accomplishes job responsibilities in a timely, safe, and professional manner.
- · Participates in client case conferences according to Home Health Care agency and procedures.
- Represents the Agency in a loyal manner and dresses appropriate to job duties.

OTHER DUTIES: Other duties as assigned.

#### SUPERVISORY RESPONSIBILITIES:

This job has no supervisory responsibilities.

#### **EDUCATION and EXPERIENCE:**

Graduation from high school or successful G.E.D. and verifiable work experience as a Personal Care Provider, preferably at least six months.

#### ABILITIES, SKILLS AND KNOWLEDGE:

Ability to read and interpret documents such as safety rules, operating and maintenance instructions, and procedure manuals.

Ability to respond effectively to the most sensitive inquiries or complaints.

Ability to write routine reports and correspondence.

Ability to speak effectively to clients and employees.

Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists.

Ability to define problems, collect data, establish facts and draw conclusions.

Ability to interpret a variety of instructions, written or oral.

Ability to improvise in an unstructured home setting.

Ability to use independent judgment to manage confidential information.

Ability to establish and maintain effective working relationships with fellow employees, the public, and supervisors.

#### SPECIAL REQUIREMENTS:

Possess a valid Colorado Driver's License with applicable car insurance, or reliable transportation to all accepted assignments.

#### PHYSICAL REQUIREMENTS:

Ability to frequently sit; use hands to finger, handle, or feel; reach with hands and arms; climb or balance; stoop, kneel, crouch, or crawl; talk and taste or smell.

Ability to frequently lift and/or move 50 pounds.

Ability to see and hear within normal parameters/ranges.

#### WORK ENVIRONMENT:

The employee is regularly exposed to fumes or airborne particles, toxic or caustic chemicals, and outside weather conditions.

Work environment is highly variable as care is performed in private homes.

Lighting, acoustics, air quality, temperature, and environmental hazards are not predictable.

The employee is frequently exposed to wet and/or humid conditions, moving mechanical parts, extreme cold and extreme heat.

The noise level in the office work environment usually is variable.

#### TRAVEL

The employee is required to drive frequently, or obtain transport frequently. Otherwise, no travel is required.
